2018/04462 - Chelmscote Manor Farm, Leighton Road, (A4146) Soulbury – Outline planning for the erection of 7 new dwellinghouses with associated works.

Many local residents attended the meeting and pointed out that the planning notices which should have been posted in Chelmscote had been put up two miles away because they showed an incorrect postcode. Matter to be taken up with the District Council and discussion of this application was deferred until the next meeting.
