PARISH COUNCIL NEWS

At the recent Parish Council meeting the Clerk asked if readers of the Newsletter could be reminded that any faulty street lights should be reported to him, as this would facilitate their speedy repair. His telephone number is 01525 370094.

The successful result of the appeal against the Council's refusal to grant permission to the developer who owns the field on the Stewkley Road site was discussed. It was felt that publicising details of this Inspectors decision might be helpful against any future applications for that site or a similar one. The Inspector considered the main issue in determining the appeal was the effect of the scheme on the character and appearance of this part of Soulbury, bearing in mind planning policy aims for the locality. These state that any new housing development should be small scale and located within existing settlements. The character of the area should be respected for instance the loss of open land of visual or physical value would be a serious erosion of environmental quality.

The Inspector found the village to have a pronounced rural character derived from the hedges, grass verges and trees. She considered Ivy Cottage of an isolated rural dwelling, still apart from the main village settlement, and the gap (the field in question) to be a valuable and open feature of that side of the road. Loosely speaking the scheme would have built development on either side, but it does not follow that the site must be suitable for new housing.

In conclusion the Inspector found the proposal would cause demonstrable havoc to the character and appearance of the village to an unacceptable degree and that <u>none</u> of the criteria for new dwellings at the edge of settlements were met. These are:- a) that the site is already bounded on 3 sides by built development; b) the development would relate well to the existing framework of the settlement; c) that it would not involve an outward extension into open countryside; d) that it would result in a clearly defined boundary to the built-up area; e) that it would be small scale rounding off and f) that it would not harm the character and identity of the settlement. A complete copy of the Inspector's letter is now with the clerk if anyone would like to see it.

The next Parish Council meeting will be on Monday 19th February.
