	23/03505: Rammamere House, Stockgrove Park, Soulbury, LU7 0BB - demolition of existing outbuuilding and construction of new 2 storey outbuilding providing garaging and office space with associated landscaping. Resubmission of 23/01848. No real objections but wanted the planners to ensure that the building was not ever used as a separate dwelling or sold separately for use as a dwelling.	
	<b>23/03736:</b> Green Farm, 2 The Green, Soubury, LU7 0DD- erection of agricultural building. Resubmision. No objections.	
	23/02067/PIP/Appeal ref: 23/00081/REF: Land at Hollingdon Road, Soulbury, LU7 0DN - permission in principle for the erection of 2 only bungalows. Application was refused. Cllr Wright has informed the residents of Hollingdon about this appeal. Received only one acknowledgement.

	8.7 Speed Indicating Device for Hollingdon Road/Stewkley Road junction Clerk read out response from Highways re moving 30 mph which bascially said it won't happen and reasons. 11	Millennium Green	
	Richard Caplan would prefer to use the Community Payback team to dig out the area in front of the gates to extend the car park to ensure he can keep them busy. Cllr Kemal will endeavour to move this project on.	Cllr Kemal
12	Public Participation	
	A resident raised the issue that the ditch along the Poppy Lane boundary had not been dug out yet. The clerk thought the ditch and hedge were done at the same time due to the whole area looking so much better but apparently the ditch had been cleared but was not dug out. She will write to Brickchill Homes again to get the ditch dug.	
13	Any other business	
	a) It was suggested the coloured lights on the Christmas Tree on the village green were a tad 'old hat' and it was more modern to have white lights. This will be considered in time for next year.	
	b) It was suggested that a note be put into the Parish News advising people who intend to have EV charging points on the houses within the conservation area that they will need planning permission to do this. Clerk will forward information to the Editor.	Clerk
	c) Cllr Wright has obtained an estimate for 'Welcome to Soulbury' gates at each entrance. This requires the purchase of 3 costing approx £5,000. This is a 'nice to do' rather than an necessity for consideration.	
	d) The clerk read the headline content of a our biodiversity duty which is a guidance. Clerk suggested using the contained action plan templete to further this but she was asked not to further take this.	
	e) The clerk had also obtained the Elections Toolkit from BMKALC. As we need to co-opt another councillor she suggested that this be looked at and use some of the templates contained to advertise the post.	Clerk
